Penalty will be levied for delayed submission and non-submission of data.

Fee in respect of candidates availing fee concession may be collected from the Government Departments concerned well in advance and the amount may be credited to Kannur University Fund. The details of such remittance shall be informed to the Examination Branch.

2011 & 2012 admission students should re-register themselves for the programme by remitting re-registration fee of ₹4000/- as per reference cited (i) above. Those candidates who have already re-registered should attach the re-registration memo along with the application form. The results of these students will be published only after the completion of re-registration process.
