The Principal/ Assistant Director may forward the applications of the students studying in their institution for examinations along with fee receipts, detailed statement of fees in the format appended and the list of eligible candidates to be registered for the examinations to the Controller of Examinations on or before the last date prescribed. Fee in respect of candidates availing fee concession may be collected from the

Government Departments concerned well in advance and the amount may be credited to Kannur University Fund. The details of such remittance shall be informed to the Examination Branch.

**Considering the Covid-19 pandemic, the Principals/ Assistant Directors shall forward the list of eligible candidates to be registered for the examinations along with the applications to the Controller of Examinations instead of submission of APC in the conventional format, on or before 15.02.2022.**

*Penalty will be levied for delayed submission and non-submission of data as per university rules/orders.*

**2014 admission students should re-register themselves for the M. C. A. programme. The results of these students will be published only after the completion of re-registration process.**

Programme for 2014 admission only - orders issued

**ORDER**

1. As per the Clause 4.1 of the Regulations for PG programmes in Affiliated Colleges implemented in the University w.e.f 2014 admission vide paper read (1) above, the minimum duration for completion of a two year PG Programme in any subject is four semesters and maximum period for completion is eight semesters (4 years).

2.Further,as per the Clause 1 of the Regulations for MCA programme in Affiliated Colleges implemented in the University w.e.f 2014 admission vide paper read (2),the minimum duration for completion of the Programme is six semesters and maximum period for completion is twelve semesters (6 years).

3. As per U.O. dated 15.05.2019, vide paper read (3) above, the maximum period for completion of the course of PG programmes in Affiliated Colleges of 2014 admission, was extended to two years more and that of 2015 admission onwards was extended for one year, after the stipulated period specified in the Regulations. Accordingly, Students of PG programmes (2015 admission), in Affiliated Colleges (excluding M.C.A.) were permitted to make use of the Mercy chance examinations up to 2020 April session.

4.Meanwhile the Examination Branch, vide paper read (4) above, forwarded the representations of students of M.Com. (2015 admission, CAS Neruvambram), requesting to grant one more mercy chance to complete their courses.Though the Examination Branch is conducting examinations in 2014 Syllabus, as per the existing Regulations, PG students of 2017 admission (excluding M.C.A.) only are eligible to attend the examinations in October 2020 session.

5. Considering the above, The Vice Chancellor ordered to place the matter before the Syndicate for consideration.

6. Subsequently,the meeting of the Syndicate vide paper read (5) above, resolved to grant one time mercy chance examination for all PG programmes in Affiliated Colleges for 2014, 2015 and 2016 admissions with October/ November 2020 session for the odd Semesters and April/May 2021 session for the Even semesters, after levying re-registration fee Rs.2,000/- . Further resolved to grant Mercy chance examination for the MCA programme, for 2014 admission only.

7. The Vice-Chancellor after considering the matter in detail, and in exercise of the powers of the Academic Council conferred under section 11(1), Chapter III of Kannur University Act 1996 accorded sanction to issue the following orders by relaxing the Clause 4.1 and 9.2 in the Regulation of the PG programmes in Affiliated Colleges implemented w.e.f. 2014 admission and Clause 1 of the Regulations for the MCA Programme in Affiliated Colleges implemented in the University w.e.f. 2014 admission, subject to reporting to the Academic Council.

i) **Permission is granted to conduct one time Mercy chance examination of all PG programmes in Affiliated Colleges for 2014,2015 and 2016 admissions with October/November 2020 session for Odd semesters and April/May 2021 session for even semesters, after levying Re-registration fee Rs.2,000/- (Rupees Two Thousand only).**

ii) **Permission is granted to conduct Mercy chance examination for M.C.A. programme for 2014 admission only, with Rs.3000/-(Rupees Three Thousand only) per paper and Rs.5000/-(Rupees Five Thousand only) as Registration fee, as and when the Examination schedule is notified by the University.**

8. The U.O. read (1) & (2) above, stand modified to this extent.
