**Regular (2019 admission only) candidates should make the payment through SBI e-pay (payment**

gateway). **Printouts of applications of those candidates who made the payment through SBI e-pay need not to be sent to the University.** This shall be retained in the Department and shall be made available for verification if the University demands. The Head of the department shall login and verify the statement of fee remittance through SBI e-pay. **An attested copy of the fee statement shall be forwarded to the Controller of Examinations, by 23.06.2022.**

Candidates with shortage of attendance **will not** be issued hall tickets unless the Head of the Department recommends and states that the shortage is within condonable limit and the application for condonation have been forwarded to the Registrar.

**Applications of eligible supplementary candidates will be received offline.** The supplementary candidates can download the registration form from the University Website. Candidates using downloaded application forms are to remit ₹50/- additionally, towards fee for application form.

Penalty will be levied for delayed submission, incorrect submission and non-submission of data.

**2012 & 2013 admission students should re-register themselves for the programme by remitting re-registration fee of ₹4000/- as per reference (i) above. Those candidates, who have already re-registered should attach the re-registration memo, along with the application form.** The results of these students will be published only after the completion of re-registration process.
