Applications of supplementary candidates will be received offline. These students can download the registration form from the University Website. Candidates using downloaded application forms are required to remit ` 50/- additionally towards fee for application form.

Penalty will be levied for delayed submission and non-submission of data as per rules. Fee in respect of candidates availing fee concession shall be collected from the Govt.

Departments concerned well in advance and the amount shall be credited to Kannur University Fund and such remittance shall be informed to the Examination Branch. **Candidates with shortage of attendance will not be issued hall tickets unless the Head of the Department recommends and states that the shortage is within condonable limit and the applications for condonation have been forwarded to the Registrar.**

The Head of the Department shall forward the print out of applications for examinations, Student Database Registration form, chalan receipts and detailed statement of fees in the format appended along with:

- (i) Photocopy of the Qualifying Certificate (+2 or equivalent) verified and attested by the Head of the Department, as per the **Clause 4.2** of UGC Notification October 2018 regarding and non retention of original certificates.
- (ii) Duly filled in Matriculation/Recognition application attested by the Head of the Department with required fee.

2009 – 2011 admission students should re-register themselves for the programme by remitting re-registration fee of `4000/- as per reference cited (i) above. Those candidates who have already re-registered should attach the re-registration memo along with the application form. The results of these students will be published only after the completion of re-registration process.
