As the registration in ABC portal is mandatory utmost care should be taken to edit/enter the correct ABC ID of every candidate in the application for registering the examination.

The printouts of online applications (Supple/Imp) need not be sent to the University in case of SBI e-pay. However, printouts of online applications of Regular (2022 Admission candidates) should be retained in the College.

The Principal/Course Director shall submit the following documents to the University on or before

10.01.2023, 5 p. m.

1. Photocopy of the Qualifying Certificate verified and attested by the Principals of Colleges /Course Directors concerned, as per the *Clause 4.2 of UGC Notification October 2018 Regarding Refund of Fees and Non Retention of Original Certificates*. (Attestation by the principal/Course Director concerned will only be accepted).
2. Original Equivalency/ Recognition Certificate from the Kannur University **(in the case of double or triple main candidates and students who passed their degrees through distance education/ open mode from Universities outside Kerala and those who obtained regular degrees with different nomenclature, as per the instructions contained in the admission prospectus.)**
3. Duly filled in Matriculation/Recognition application attested by the principal/Course Director. (Students who passed their qualifying examination from other Universities/Board)
4. Printouts of admission data verified and submitted already.

The eligible candidates who receive the grant directly to their bank account shall **either remit the examination fee online (SBI e pay) during registration without opting fee concession or remit the amount to the University as and when it is received from the Government Department concerned**. These candidates shall **submit the affidavit in annexure I if the examination fee is not remitted during registration**.

The candidates who receive the grant through the institution's bank account shall opt for fee concession during registration. The Head of the Institution shall credit the examination fees of these candidates to the Kannur University Fund and inform details of such remittance to the Examination Branch without delay. If any candidate receiving grant through the institution's bank account has remitted the examination fee during registration, the principal of the College/Course Director shall reimburse the amount to the candidate.

The Principals/Course Director shall log in and download the detailed statement of fees remitted by the regular candidates and forward an attested copy of the same, along with the affidavits submitted by the candidates receiving grant directly to their bank account, who have not remitted the examination fee during registration before the last date prescribed.

Penalty will be levied for delayed submission/incorrect submission/ non-submission of data/Applications, as per the university rules. The deadline for submitting applications and data as per the above schedule will not be extended.

Candidates with shortage of attendance will not be issued hall tickets unless the Principal recommends and states that the shortage is within the condonable limit and the application for condonation have been forwarded to the Registrar.

***All candidates** (including candidates availing fee concession) shall remit the application fee of **₹50/-** online **through SBI e-pay**. Registration process will be completed only after remitting the applicable fee. *Any amount due to the University shall be remitted on reimbursement of the fee from the Government Department concerned or on remittance by the candidate concerned, before publication of results or else the results will be withheld.*

The Schedule of Examinations **will not be** intimated to the candidates individually. The timetable will be published on the University website. Candidates registered for the examination shall visit the university website, for further information in this regard.

The centre of Examinations will be the respective colleges.

The date of publication of results will be announced later.
