Applications for examination registration can be downloaded from the university website <www.kannuruniversity.ac.in>.

The Head of the Department of Law shall forward the application for examination, challan receipt, Attendance Progress Certificate (APC) and the statement of fees, on or before the last date prescribed, to the Controller of Examinations. Penalty will be levied for delayed submission and non- submission of data as per rules. Fee in respect of candidates availing fee concession shall be collected from the Government Departments concerned well in advance and the amount shall be credited to Kannur University Fund and such remittance shall be informed to the Examination Branch.

Candidates with shortage of attendance will not be issued hall tickets unless the Head of the department recommends and states that the shortage is within condonable limit and the applications for condonation have been forwarded to the Registrar.

Students of 2009, 2010 and 2011 admissions should re-register themselves for the programme by remitting re-registration fee of ₹4000/- as per reference cited (1) above. Those candidates who have already re-registered should attach the re-registration memo along with the application form for examination. The results of these students be published only after the completion of re-registration process.

The application for re-registration (in the format available on the university website) along with the challan receipt should be submitted to the Registrar whereas, the application forms for examinations along with the challan receipt should be submitted to the Controller of Examinations.
