**Applications of eligible supplementary candidates will be received offline.** The supplementary candidates can download the registration form from the University Website. Candidates using downloaded application forms are required to remit ₹50/- additionally towards fee for application form.

The Head of the Department may forward the applications for examinations along with chalan receipts and detailed statement of fees, in the format appended, to the Controller of Examinations on or before the last date prescribed.

**Considering the Covid-19 pandemic, the Head of the Departments shall forward the list of eligible candidates to be registered for the examinations to the Controller of Examinations on or before 26.04.2021 instead of submission of APC in the conventional format,**

Penalty will be levied for delayed submission and non-submission of data.

Fee in respect of candidates availing fee concession may be collected from the Government Departments concerned well in advance and the amount may be credited to Kannur University Fund. The details of such remittance shall be informed to the Examination Branch.

**2010 – 2011 admission students should re-register themselves for the programme by remitting re-registration fee of ₹4000/- as per reference cited (i) above. Those candidates who have already re-registered should attach the re-registration memo along with the application form.** The results of these students will be published only after the completion of re-registration process.
